- a. Murfin reported on the October financials. Shaw made comments.

### 6. Director's Report

- a. Shaw reported on the advocacy issues currently going on.
  - i. \$50 million interruption grant was approved to include hotels, restaurants, attractions, salons, barbershops, private event venues, etc.
  - ii. Webinar hosted by Secretary Hurst on Friday giving details about the grant.
  - iii. The grant opens Monday, November 16<sup>th</sup> at 8am and closes on Wednesday, November 25<sup>th</sup> at 11:59pm.
  - iv. This is not first come first serve. All applications will be reviewed, and decisions are expected to be made in December.
- b. Shaw continues to attend the regional tourism meetings each month.
- c. Shaw attended the Issue 1 rally at the AMP. Issue 1 did pass in the election.
- d. Shaw reported on the STR data for occupancy, ADR, and REVPAR for YoY.
- e. Shaw reported on the updated dashboard sales numbers and tax collections.
